STATE OF OHIO ARTICLES OF INCORPORATION

PARMA EVANGELICAL LUTHERAN CHURCH

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under the general Corporation Act of Ohio, do hereby certify:

FIRST: The name of said corporation shall be: Parma Evangelical Lutheran Church.

<u>SECOND</u>: The place in this state where the principal office of the corporation is to be located is: 2110 North Avenue, Parma, Ohio, Cuyahoga County.

THIRD: The purpose or purposes for which said corporation is formed are:

- 1st: To Glorify God and to help in the extension of His Kingdom among men for their salvation by promoting and disseminating the Christian religion as expressed in the doctrine and practice of The Evangelical Lutheran Church;
- 2nd: To promote the cause of Christian religion and to propagate the principles of faith, morals, and religious beliefs as enunciated by the Evangelical Lutheran Church, by means of discussion, teachings and distribution of information through the usual and customary channels.
- 3rd: For the purpose of providing a place of worship for its members and for conducting said place of worship according to the rules, regulations and customs of the Evangelical Lutheran Church;
- 4th: For receiving, holding and disbursing gifts, bequests and funds arising from various sources;
- 5th: For the buying, acquiring, owning, selling and otherwise controlling and managing suitable real estate and buildings of every nature and description, especially such as may be necessary for the fulfillment of the purposes and objects of this Corporation:
- 6th: And for the doing of all things necessary and incident thereto, in accordance with the laws of the State of Ohio and these United States.

<u>FOURTH</u>: The following persons shall serve said corporation as trustees until the first annual meeting or other meeting called to elect trustees.
